

Board of Studies (BoS) committee meeting for UG - B.Tech CSE (Cyber Security)
Programme for R20 (CBCS) Regulations held on 09-06-2024

The Chairman - Board of Studies, B.Tech CSE (Cyber Security) welcomed and introduced the members of Board of Studies and thanked each one of them for sparing their valuable time to attend the meeting.

The minutes of the Board of Studies meeting held on 9th June, 2024 were communicated to the members. The comments received have been incorporated and placed for confirmation.

Discussed the course structure of V, VI, VII & VIII semesters and detailed syllabus of V & VI semesters (III year) - R20 Regulations.

They recommended the following resolutions.

Resolution-1: Discussed and approved the course structure of V, VI, VII and VIII semesters along with Professional Electives, Job oriented Electives and Open Electives of R20 regulations and BoS committee has recommended the following changes.

01. In line with National Education Policy 2020, the committee has suggested to include NPTEL/MOOC course in VI semester which is an alternative to the Professional Elective-II course.

- The committee is also suggested to allow doing this NPTEL/MOOC course either in V semester to facilitate the students for GATE exam preparation.
- Those who are not registered the NPTEL/MOOC course may take any one of the courses available in Professional Elective-II in VI semester.
- The students who completed this NPTEL/MOOC course, those are to be exempted from Professional Elective-II in VI semester.
- In case of the NPTEL/MOOC course, the result will be published in VI semester mark sheet in place of Professional Elective-II.

02. The committee is recommended to include some advanced Cyber security specialized courses, "Vulnerability Assessment and Penetration Testing" course is included in Professional Elective-IV of VII semester.

The detailed syllabus of this course will be discussed in the upcoming BoS meeting.


Resolution-2: Discussed and approved the detailed syllabus of V and VI semesters along with Professional Electives, Job oriented Electives and Open Electives of R20 regulations and BoS committee has recommended the following suggestions.

01. For every course, the committee is recommended to include the available latest versions of prescribed text books.
02. The committee is also recommended to include the web reference links preferably NPTEL.

Other points:

- The committee is appreciated the course contents of "Artificial Intelligence", as the syllabus is in accordance with the NPTEL.
- As per the suggestions of Industry expert member Mr. Anil Rachamalla, the committee is recommended to form Cyber security club and to encourage them for participating in external events.
