ADMISSIONS MANUAL

The regulations/guidelines specified herein are applicable for admission of candidates to various Diploma,UG and PG programs offered by Swarnandhra College of Engineering & Technology, Seetharamapuram, Narsapur, from the academic year 2019-20. These are subject to change according to the orders of the UGC, the AICTE, the State Government Andhra Pradesh Higher Education Regulatory and Monitoring Commission (APHERMC) and the Conveners of various UG and PG Common Entrance Tests etc from time to time.

1. **PREAMBLE :**

The regulations stated herein shall be called the "SWARNANDHRA COLLEGE OF ENGINEERING & TECHNOLOGY(AUTONOMOUS)Admissions & Academic Regulations".

These regulations will be in force from the academic year 2020-2021.

In the event of any doubt requiring clarification about the interpretation of these regulations, the matter shall be referred to the Governing Body of the Academy and its decision shall be final.

4 : **ADMISSION PROCEDURE:**

4.1 **Undergraduate Programmes (UG):**

The admission into undergraduate engineering programmes (B.Tech) for all the branches of study are made as per the relevant Rules of the Govt. and norms/guidelines of the State Council of Higher Education:

- a. 70% of seats under Category-A (based on the rank obtained in state level entrance examination-APEAMCET) will be filled by the Convener, APEAMCET.
- b. 30% of seats under Category-B will be filled by the management as per the relevant rules of the State Govt. and guidelines of the State Council of Higher Education issued from time to time.

4.2 **Admission to the second year of 4-year B.Tech Degree (Lateral Entry) Programme in Engineering:**

Seats upto 10% of the sanctioned intake of each programme of undergraduate course shall be filled by the Convener, APECET as lateral entry admission into second year of B.Tech programme based on the merit ranks obtained by the students in APECET (State Level Common Entrance Test).

4.3 **Spot Admission Procedure for B.Tech. 4 year Course:**

Any seats left vacant in the convener quota will be filled by the institution based on the guidelines given by Convener APEAMCET.

Procedure:

The College issues an advertisement after necessary approval. The spot admissions will be made according to the guidelines issued from time to time by convener APEAMCET.

All admissions made at institution level (Spot Admissions and Category-B) are subject to approval of competent authorities.

4.4 **Spot Admission Procedure for B.Tech Lateral Entry:-**

Admission will be made based on the guidelines issued by the Convener APECET.

Procedure:

The College issues an advertisement after necessary approval. The spot admissions will be made according to the guidelines issued from time to time by the Convener APECET.

All admissions made at institute level (Spot Admissions) are subject to approval of competent authorities.

5. **POST GRADUATE ADMISSION (PG):-**

The admission into Postgraduate engineering programmes (M.Tech) for all the branches of study are made as per the norms of Andhra Pradesh Higher Education Regulatory and Monitoring Commission (APHERMC) and the Andhra Pradesh State Government.

Eligibility and Selection Procedure for MBA and MCA in SCET.

Should have passed recognized Bachelors Degree Examination of minimum three years duration with at least 50% marks (45% marks in case of SC,ST reserved categories) in the qualifying examination.

a) The qualifying Degree obtained by Distance Mode Program should have recognition by joint committee of UGC, AICTE and DEC.
b) The candidates who are appearing for the final year degree examination shall also be eligible to appear for APICET – 2020
c) Admission into any college depends on its Recognition/Affiliation by the Statutory Bodies.
d) Qualifying marks in APICET - 2018 is 25% and no minimum marks are prescribed for SC/ST candidates.

AP ICET 2020 Counselling

The AP ICET 2020 Counselling has been started from 24th January 2021. Candidates have to attend the web based counselling. Candidates, who successfully clear their entrance exam, get a call for counselling round. It is important for candidates to attend counselling round for taking admissions into various institutes.

The seat allotment is on the basis of rank obtained by candidate & some other conditions laid down by the university for admission. Candidates also have to pay the AP ICET counselling fee of INR-1200 (OC/BC) and INR-600 (SC/ST). The counselling fee have to be paid before verification of certificate.
