ORDER

The All India Council for Technical Education, New Delhi in its letter 1st read above, has accorded approval for establishment of certain private Engineering Colleges in the State for the academic year 2001-2002.

2. Having regard to the approval of the All India Council for Technical Education, New Delhi and in the circumstances stated by the Commissioner of Technical Education in the reference 2nd read above, the Government hereby accord permission for the establishment of private Engineering Colleges with the disciplines and intake and period of permission as shown in the Annexure to this order, under section 20 of the A.P. Education Act 1982. The above permission accorded herein is subject to the condition that the colleges shall abide by the rules and regulations issued by the Government from time to time in respect of the functioning of the colleges. In case of any deviation in fulfilling the normal and standards stipulated by the All India Council for Technical Education or failure in implementing the rules and regulations of the State Government issued from time to time, the permission sanctioned now is liable for cancellation without any notice.

3. The managements of the colleges may seek affiliation either to Jawaharlal Nehru Technological University, Hyderabad or to the University in whose territorial Jurisdiction the college is located.

4. The above permission is also subject to conditions laid down by the All India Council for Technical Education, New Delhi from time to time.

5. The Commissioner of Technical Education, A.P. is requested to obtain an undertaking from the management of the colleges to make up the deficiencies and bring accommodation and infrastructure facilities, in conformity with the norms stipulated by the All India Council for Technical Education within a period of thirty days. If the deficiencies are not made up, the

Government reserves the right to cancel the permission for admission in the next academic year i.e. 2002-2003. Consequential losses, if any shall be borne by the management alone without any liability to the Government.

6. The Commissioner of Technical Education, is requested to take necessary action accordingly.


