- **Agenda 5:** Any other matter with the permission of chair.

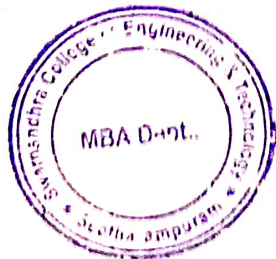
Resolution 5: The board suggested to organise one Industrial Visit for each semester to invoke entrepreneurial motive amongst the students.
