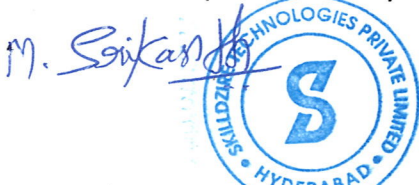

I. PREAMBLE / BACKGROUND

2. Workshops and Competitions: The Second Party will collaborate on organising workshops, technical talks, and student competitions aimed at improving skill sets and industry awareness.
3. Coordination for Knowledge Enhancement: The Second Party will assist in coordinating knowledge enhancement programs such as Faculty Development Programs (FDP) and other mutually agreed initiatives.

V. IMPLEMENTATION OF THE MEMORANDUM

1. Designated Representatives: Each party will designate representatives to oversee the implementation of the MoU, monitor progress, and address any arising issues.
2. Review and Evaluation: Regular reviews and evaluations will be conducted to assess the effectiveness of the collaboration and identify potential areas for improvement or expansion of activities.


